# **Wyoming Wildfire Recovery Guide**

# Assistance for Private Landowners, Small Businesses, Homeowners, and Non-profits

During the 2024 wildfire season, more than 2,000 wildfires burned in excess of 850,000 acres across the State of Wyoming, a clear demonstration of the expanding fire season and an uptick in fire frequency. Unusually, about 70% of that acreage was on private and state lands, whereas past large fires have traditionally affected federal land, which is often forested. Recognizing the urgent need for resources to address ongoing wildfires and provide essential relief to affected private landowners, the Wyoming Grants Management Office (GMO) researched federal funding that could potentially be leveraged for wildfire recovery efforts on private property. This document identifies federal funding programs that wildfire-impacted households, landowners, small businesses, and non-profits may be able to apply for directly.

## **Summary of Funding Programs**

The GMO identified 18 funding programs that could benefit households, landowners, small businesses, and non-profits impacted by recent wildfires.

This report provides a summary of each of these programs, including a brief description of the grant or loan program and information on the entities that may be eligible to apply for funding. As additional programs are authorized by our Federal and State partners, the GMO will update this guide.

# How can I determine if I am eligible for this funding?

The programs included in this guide have specific eligibility criteria, and many programs are only available in counties officially designated as disaster areas due to recent wildfires. We encourage you to contact the program representatives included in this guide to confirm your eligibility and receive guidance on the application process. To do so, you can:

## **USDA Farm Services Agency (FSA) Programs**

#### **Emergency Conservation Program**

Assists farmers and ranchers in repairing farmlands damaged by natural disasters, covering eligible uses such as debris removal, land shaping, and fence restoration. There is a \$500,000 per-person limit.

ELIGIBLE ENTITIES: Farmers and ranchers are eligible for funding

#### **Emergency Forest Restoration Program**

Supports non-industrial private forests with forest restoration when disasters create new conservation problems that can harm natural resources or significantly affect future land use. There is a \$500,000 per-person limit.

ELIGIBLE ENTITIES: Forests must be owned by nonindustrial private individuals, groups, associations, corporations, or private legal entities

#### Farm Storage Facility Loan Program

Provides low-interest financing for producers to build, repair, replace, or upgrade facilities to store commodities. Participants may be able to borrow up to \$500,000 per loan, with a minimum down payment of 15%.

ELIGIBLE ENTITIES: Landowners, landlords, leaseholders, tenant, or sharecroppers

#### **Livestock Forage Disaster Program**

Offers financial support to livestock producers who experience grazing losses due to events on federally managed rangelands. No person or legal entity (with exceptions) may receive, directly or indirectly, more than \$125,000 total.

ELIGIBLE ENTITIES: Livestock producers who own or lease grazing land or pastureland in affected areas

#### **Noninsured Crop Disaster Assistance Program**

Offers financial support to producers of non-insurable crops who experience losses due to natural disasters. A maximum payment limitation is provided of \$125,000 for losses to crops with catastrophic coverage and a \$300,000 maximum payment limitation for losses to crops with buy-up coverage.

ELIGIBLE ENTITIES: Landowners, tenants, or sharecroppers may be eligible

#### Emergency Assistance for Livestock, Honeybees, and Farm-Raised Fish Program

Provides financial assistance to eligible producers of livestock, honeybees, and farm-raised fish for losses due to disease, adverse weather events, and loss conditions, including wildfires. Payment calculations vary by type of loss and species.

**ELIGIBLE ENTITIES:** Producers impacted by qualifying natural disasters



### **USDA FSA Programs, Continued**

#### **Tree Assistance Program**

Provides financial support to landowners who have lost trees due to natural disasters like wildfires. It covers 65% of replanting costs for trees with more than 15% mortality and, where applicable, 50% of the rehabilitation costs for trees with over 15% damage or mortality.

ELIGIBLE ENTITIES: Orchardists and nursey tree growers whose trees are produced for commercial purposes

#### Conservation Reserve Program - Emergency Haying and Grazing

Compensates farmers and ranchers for removing environmentally sensitive land from production and establishing long-term vegetation. In the event of a natural disaster, land may also qualify for emergency having and grazing.

ELIGIBLE ENTITIES: Farmers, ranchers, and producers in eligible counties

#### **Livestock Indemnity Program**

Provides benefits to livestock producers for livestock deaths in excess of normal mortality caused by adverse weather

ELIGIBLE ENTITIES: Livestock producers who own/lease grazing or pastureland in areas affected by drought or fire

#### **Emergency Farm Loans**

Provides loans to help producers recover from production and physical losses due to natural disasters. Producers can borrow up to 100% of losses to a maximum amount of \$500,000.

ELIGIBLE ENTITIES: Farmers located in counties that are contiguous to the declared, designated, or quarantined area may qualify for emergency loans

# **USDA Programs**

#### **Federal Crop Insurance Program**

Provides crop insurance to farmers and ranchers to protect them against adverse weather events, natural disasters, or falling prices.

ELIGIBLE ENTITIES: Farmers and ranchers enrolled prior to the impact-causing event

#### Disaster Supplemental Nutrition Assistance Program (D-SNAP)

Offers food assistance to low-income households with food loss or damage caused by a natural disaster.

ELIGIBLE ENTITIES: Individuals in a declared disaster county with eligible FEMA Individual Assistance



### **USDA Natural Resources Conservation Service (NRCS) Programs**

#### **Emergency Watershed Protection Program**

Provides assistance for disasters affecting watersheds, including debris removal, streambank reshaping, drainage corrections, vegetative cover on eroding lands, and levee repairs. The cost share amount varies.

ELIGIBLE ENTITIES: Private landowners can pursue this program through a sponsor, which could be a city, county, town, conservation district, or federally recognized Tribal Government or Tribal Organization

#### **Environmental Quality Incentives Program**

Assists producers in conservation efforts, including improving water, air, ground, and surface water quality. Financial assistance amounts are determined on an annual basis.

ELIGIBLE ENTITIES: Farmers, ranchers, and forest landowners are eligible if they own or rent agricultural land

## **USDA Rural Development (RD) Programs**

#### Single Family Housing Guaranteed Home Loan Program

Assists approved lenders in providing low- and moderate-income households the opportunity to purchase, build, rehabilitate, improve or relocate a dwelling in an eligible rural area. Lender information is available here.

ELIGIBLE ENTITIES: Applicants must meet area and income eligibility requirements and other program requirements

#### **Multifamily Housing Programs**

Assists property owners through loans, loan guarantees, and grants that enable owners to develop and rehabilitate properties for low-income, elderly, and disabled individuals and families as well as domestic farm laborers.

ELIGIBLE ENTITIES: Multifamily Housing works with the owners of its direct and farm labor housing loan properties

# **U.S. Small Business Administration (SBA) Programs**

#### Physical Disaster Loans and Economic Injury Disaster Loans (Presidential Disaster Declaration)

Private nonprofits that provide essential services of a governmental nature are eligible for low-interest federal disaster loans; FEMA may also provide these private nonprofits with Public Assistance grants for their eligible costs.

ELIGIBLE ENTITIES: Private Non-Profit organizations that provide essential services of a governmental nature in eligible counties. For more information about the counties eligible for assistance, please contact Amy Lea, Wyoming District Director, at (307) 247-3191 or amy.lea@sba.gov.

#### Economic Injury Disaster Loans (Disaster Declaration Due to Designation by the Secretary of Agriculture)

Provides loans to help cover the costs and expenses that eligible entities would have been able to handle if the disaster did not happen.

ELIGIBLE ENTITIES: Small businesses, small agricultural cooperatives, small businesses engaged in aquaculture, and most private non-profit organizations located in eligible Counties.
